Our goal is to develop products offering better efficacy, safety and convenience, meeting women's needs throughout their life span.

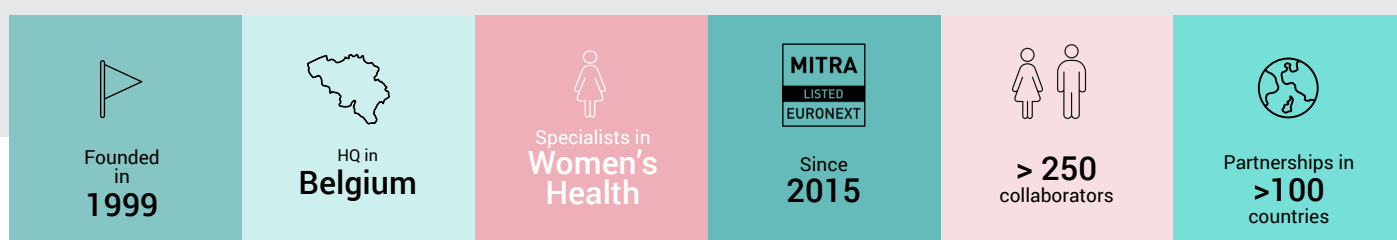

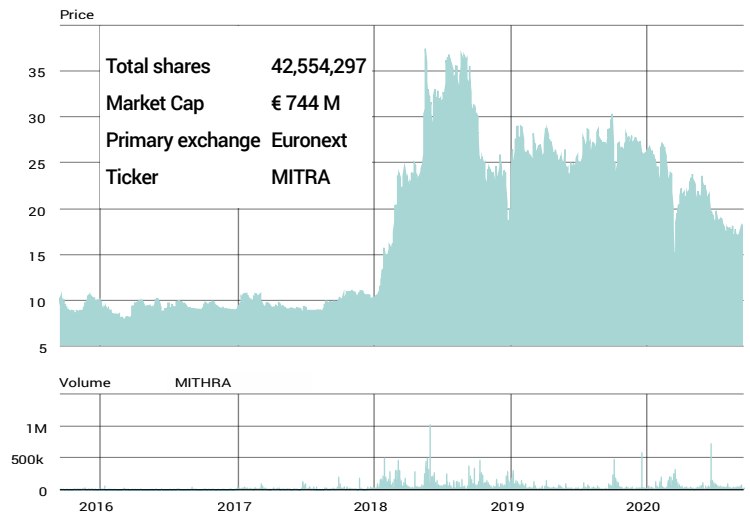
Share Structure

as of June 30, 2020

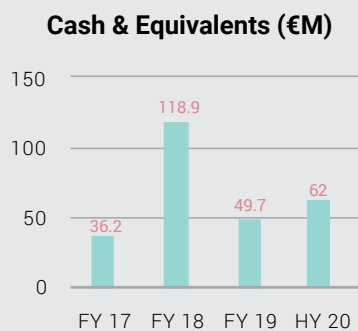
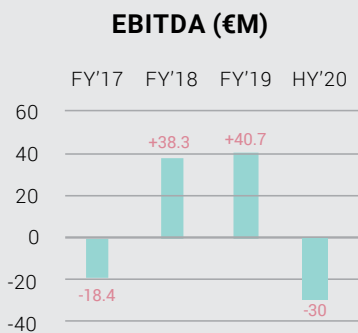
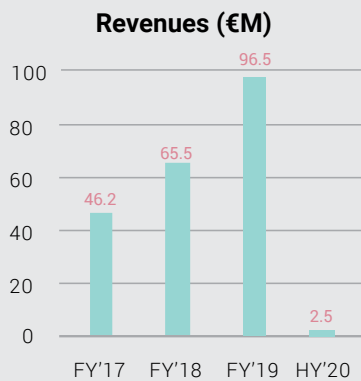

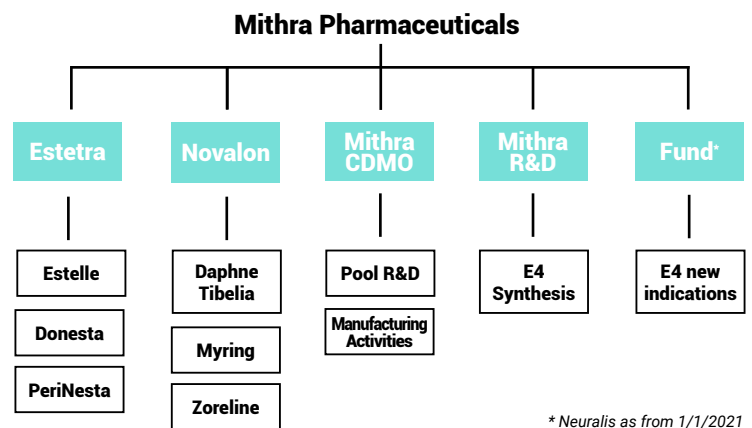
